## Pro Bono Attorney Helps a Victim of Domestic Violence



Rosette, a victim of domestic violence, was forced to leave her home to escape her abuser. With no financial support to care for her adult disabled son, Rosette desperately needed the proceeds from the home she owned with the father of her children, but he refused to sell it. Pro bono attorney **Barry Davidson, Hunton & Williams**, filed a lawsuit for partition to force the sale of the home. He was successful in getting a final judgment awarding Rosette \$45,000. She now has sufficient funds to take care of herself and her disabled son. Without Barry's pro bono help, Rosette would not have received justice. # LSGMI Strives to Preserve Affordable Housing

## Successful Affordable Housing Condominium Conversion



With help from LSGMI, Town Park Village, a limited equity cooperative development in Overtown which has been on the verge of collapse for more than 30 years, will be transformed into a viable affordable living community. Built in 1970 in an effort to increase affordable housing,



the 151 unit apartment complex eventually fell on hard times, was unable to operate, and was threatened with foreclosure by HUD.

Committed to the preservation of affordable housing, the Local Initiatives Support Corporation (LISC) and the Turkel Foundation convinced HUD to forbear on their mortgage, and developed a plan to convert the ailing cooperative into an affordable condominium. Shahrzad Emami and John Little, lawyers in LSGMI's Community Economic Development Unit, were asked to serve as corporate legal counsel to the Town Park Board of Directors and handle the condominium conversion process, services which would have cost at least \$100,000 in private legal fees.

With LSGMI's assistance, the residents recently voted in favor of the condominium conversion which will give each resident a fee simple ownership interest in their unit which will each be rehabilitated. To ensure that the property remains affordable for the residents of Town Park, the units will be encumbered by affordability restrictions.

At the end of the day, the residents of Town Park Village will be able to keep their homes and own a valuable piece of real estate that can continue to operate for generations as a safe affordable housing community. This conversion is very rare and is truly a success story which will likely serve as a case study for these types of forgotten HUD insured properties.

## Settlement with MDHA and HUD Benefits Low-Income Tenants



In August 2007, the United States Department of Housing and Urban Development took control of the Miami-Dade Housing Agency (MDHA) due to financial and operational mismanagement. After HUD's takeover, the Section 8 voucher program became completely dysfunctional. Housing assistance was terminated without fair hearings,

paperwork needed to move was not provided in a timely manner, and the office was often closed without notice, creating financial and emotional turmoil for many Section 8 participants and, in the worst cases, resulting in homelessness.

Despite numerous demands, MDHA and HUD failed to correct these significant problems. In July 2008 LSGMI and Florida Legal Services filed a federal lawsuit on behalf of three single mothers who were improperly terminated from the Section 8 voucher program. The lawsuit asked the Court to order MDHA to restore the women's rental assistance, make permanent changes to Section 8 program operations, and award money for our clients' economic and emotional damages.

Immediately after the lawsuit was filed, MDHA agreed to restore our clients' rental assistance. After an early mediation, the parties reached a settlement awarding \$60,000 for our clients and making systemic changes to the program's operation: specific timeframes to process paperwork allowing participants to move and to approve new housing, and administrative safeguards to ensure due process before housing subsidies are terminated. This settlement ensures that Section 8 participants will be treated fairly and can continue to benefit from this valuable government housing program

Olga is separated from her husband and works full time to support her two minor children with no financial help from her husband. She came to LSGMI for help because her tax refund of \$3,920 for 2004 was frozen, and the IRS claimed she owed \$5,716 for 2005 plus continuing interest and penalties. LSGMI filed a Petition in Tax Court and an audit reconsideration to support Olga's claims for the Earned Income Credit, dependency exemption and child tax credit for both years. Counsel for the IRS conceded that Olga was entitled to the claims on her returns, and she received her 2004 refund and the IRS erased the debt for 2005.
