## Former UK Information Commissioner Richard Thomas CBE Joins Hunton & Williams

Richard Thomas was the UK's Information Commissioner from November 2002 until his retirement at the end of June 2009. He was appointed by HM The Queen and held independent status, reporting directly to Parliament, on a range of regulatory, promotional and advisory responsibilities under the Data Protection Act 1998, the Freedom of Information Act 2000 and related laws. He also served as a member of the European Union's Article 29 Working Party on Data Protection. In June 2009, Richard was awarded Commander of the British Empire ("CBE") for public service.

Richard joins Hunton & Williams' Privacy and Information Management practice, one of the world's leading privacy and data protection practices. The AJTC reviews the accessibility, fairness and efficiency of the arrangements for resolving disputes between governmental bodies and individuals. He was also appointed to the Board of Directors of

the International Association of Privacy Professionals ("IAPP"), the world's largest association of privacy professionals.

He previously held various public appointments including membership on the Lord Chancellor's Civil
Justice Review Advisory Committee and on the Board of the Financial
Ombudsman Service. He currently serves as Deputy Chairman of the
UK Consumers Association and has been awarded an honorary
Doctor of Laws by the University of Southampton and is a visiting Professor at the University of Northumbria.
