## **Pate joins Chevron**

Energy company Chevron Corporation today hired the former assistant attorney general at the US Department of Justice's antitrust division, R Hewitt Pate, as vice president and general counsel from 3 August.



Pate, 47, joins the company from Hunton & Williams LLP, where he was head of the firm's global antitrust practice. He returned to Hunton & Williams in 2005 when he left the DoJ. He had practised at Hunton & Williams from 1999 to 2001 before he entered the government.

As chief legal officer, Pate will direct Chevron's worldwide legal affairs and serve on the company's executive committee.

"Leaving good friends and our work together building a growing and successful team is difficult, but the chance to take a leadership role at Chevron is a once in a lifetime opportunity," Pate says.
