### Maya Eckstein Receives Metropolitan Richmond Women's Bar Association Women of Achievement Award

Home at Saint Joseph's Villa, a two-year
transitional housing program for homeless
women and their children. She received
national recognition for her pro bono

efforts and public service in 2003 as a recipient of the third annual Sandra Day O'Connor Award for Professional Service by the American Inns of Court.

Eckstein's professional successes include, among others, being AV Rated in Martindale-Hubbell, listed among the *The Best Lawyers in America*,

recognized as an "Up and Comer" in Chambers USA, and named one of *Virginia Business* magazine's "Legal Elite" and *Inside Business*'s "Top 40 under 40."
