Hunton &Williams represented Smithfield Foods, Inc. in its \$815 million sale to JBS S.A., in Brazil; and Philip Morris International, Inc., in its \$293.5 million acquisition of Compañía Colombiana de Tabaco S.A. and its \$930 million sale of Kibon (Brazil) to Unilever.

#### **Banking and Finance**
